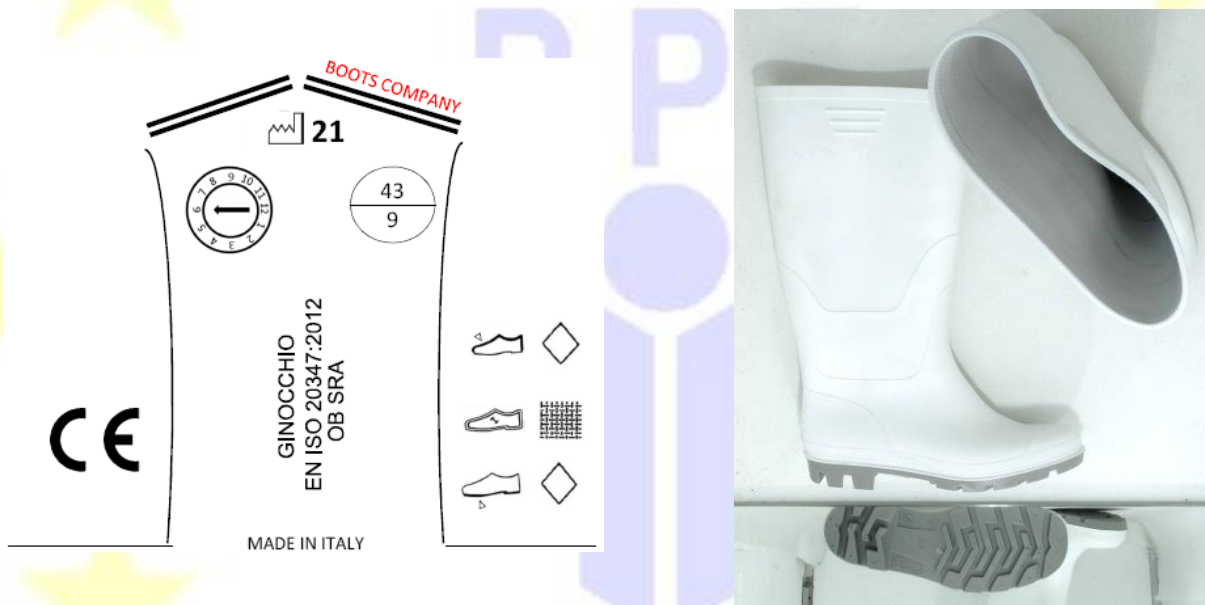
basic requirements for occupational footwear (OB) (see table 2 and 3 of EN ISO 20347:2012): all mandatory ones, among which:

- surface: ceramic / lubricant: detergent solution.

Marking:

printed on the outsole and upper and containing the following information:

- **CE Marking**;
- Name of the Manufacturer;
- designation of the footwear;
- nr. and year of the Standard of reference + protection symbols;
- size of the footwear;
- production date (with clock indicator for the month and "industry" pictogram for the year);
- additional information: "Made in.../Fatto in...", composition material.



NOTE: the Technical File contains a more detailed description of the PPE (material, method of assembly, photographs or drawings), performance data, safety functions and level of protection, elements of conformity to the basic and supplementary requirements.
